**Object:** Organization of *an Intensive Spanish course*

#### AND

The receiving organization (course provider) **EUREKA ACADEMIA DE ESPANOL ARENAL,26 - Madrid, Spain**, represented by **Ángel Luis Piñuela Pérez**.

#### ARTICLE 1: OBJECTIVES

Within the framework of Erasmus+, the Intensive Spanish course for Mr Francesco Finocchiaro is organized, following the rules of this mobility agreement, in order to reach the following aims:

##### **Intensive Spanish: (30 hours)**

- Development of the language knowledge, improving grammar and increasing vocabulary;
- Improvement of overall communicative skills and fluency, with a focus on the four skills;
- Work on specific pronunciation difficulties and expand the range of language you use in real-life situations.

#### ARTICLE 2: DUTIES OF THE COURSE PROVIDER

Before the mobility starts, the course provider will send a pre-course needs analysis to ascertain the teachers' precise academic needs.

During the course, the participants will receive all of the course content and material, even digitally. In case the participants won't have a laptop or a tablet, they will be provided paper copies for classroom use.

At the end of the course, the course provider (receiving organisation) will issue to the participant a proper certificate in compliance with the Erasmus+ specifications. It must include the name of the participant, the goal of the mobility, start date and end date of the course.

In addition, the course provider will issue an invoice or an equivalent document to prove subscription and payment of the course. It must include the amount paid, the name of the participant, the title of the course, the start date and the end date.

### **ARTICLE 3: TEACHER INVOLVED IN THE PROJECT**

The teacher involved in the mobility will be:

Throughout the entire stay, the teacher will respect the rules of the receiving organization, thoroughly following the activities to be carried out within the mobility project.

### **ARTICLE 4: TEACHER'S TRAVEL**

The teacher will travel autonomously to the destination country and receiving organization, as it has been described in the Erasmus+ project.

### **ARTICLE 5: ACCOMODATION**

During his stay, according to what described in the Erasmus+ project, the teacher will autonomously provide for his accommodation and what necessary.

### **ARTICLE 6: FINANCIAL SUPPORT**
